4.	f. FIRST AID MEASURES:								
General:  Eye Contact:	Move the exposed person to fresh air at once. Get medical attention if any discomfort continues. In all cases of doubt, or if symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person.  Make sure to remove any contact lenses from the eyes before rinsing. Promptly wash eyes with plenty of water while lifting the eyelids. Continue to rinse for at least 15								
Skin Contact:	minutes. Contact physician if irritation persists.  Remove affected person from source of contamination. Remove contaminated clothing. Wash the skin immediately with soap and water or use a proprietary skin cleanser. Do not use solvents or thinners. Get medical attention if irritation persists after washing.								
Inhalation:	Move the exposed person to fresh air at once. For breathing difficulties oxygen may be necessary. If breathing stops, provide artificial respiration. Keep the affected person warm and at rest. Place in recovery position and get prompt medical attention.

5.	5. FIRE FIGHTING MEASURES:								
Extinguisher Types Recommended:	Fire can be extinguished using: Carbon dioxide, foam, dry chemicals, halogenated hydrocarbons, sand, dolomite, etc. Do not use water.								
Special Precautions:	Avoid breathing fire vapours. Cool containers exposed to flames with water until well after the fire is out. Keep run-off water out of sewers and water sources. Dike for water control.

Special Precautions (continued):	Fire will produce dense black smoke containing hazardous products of combustion. Decomposition products may be a hazard to health. Appropriate self-contained breathing apparatus may be required.									
6. ACCIDENTAL RELEASE MEASURES:										
Spill Cleanup Methods:	Extinguish all ignition sources. Avoid sparks, flames, heat and smoking. Ventilate. Clean-up personnel should use respiratory and/or liquid contact protection. Absorb in vermiculite, dry sand or earth and place into containers. Do not allow to enter drains or watercourses. If it does the local water company should be contacted immediately, in case of contamination of streams, rivers or lakes, the National Rivers Authority. Clean preferably with a detergent, avoid use of solvents.									
7. HANDLING AND STORAGE:										
Recommended Storage Conditions:	Flammable/combustible – keep away from oxidisers, heat and flames. Keep in cool, dry, ventilated storage and closed containers. Keep in original container. Store in accordance with the conditions of the licence which is necessary under the Petroleum (Consolidation) Act. See the HSE guidance note Storage of Flammable Liquids in Containers.									
Temperature:	Cool. Between 5°C and 25°C.									
<b>Electrical Grounding:</b>	Yes.									
Storage Section of Area:	Flammable liquid storage.									
Handling Precautions:	Avoid spilling, skin and eye contact. Keep away from heat, sparks and open flame. Ventilate well, avoid breathing vapours. Use approved respirator if air contamination is above accepted level. Use explosion proof electric equipment. Vapours are heavier than air and may spread along floors. They may form explosive mixtures with air. Prevent the creation of explosive or flammable mixtures and avoid vapour concentrations higher than the OEL. Always keep in containers made of the same material as the supply container. The product may charge electrostatically. Use earthing leads when transferring from one container to another. Wear anti-static footwear and clothing, and floors should be electrically conductive.
